

Privacy Policy

Barryroe Offshore Energy PLC (“Barryroe” or “Company”) recognises and respects the importance of the privacy of our visitors of our websites and users of online systems. The purpose of this statement is to clearly detail how the Company processes that data, how we respect your privacy and how you may exercise your right to receive a copy of that data. At all times, we treat your data in compliance with the Data Protection Act 1988 and EU-wide regulations.

This policy accounts for the personal data and cookies, etc (if any), used by our websites and online systems. If you do not agree with the terms herein, please do not use this website or online systems and delete the cookies (if any) placed by the website.

Note that “personal data” in the context of the GDPR regulation and the Data Protection Act just means data that can be identified with a particular individual (we can identify that the data relates to you through your name and address). It does not mean sensitive data – we do not obtain or hold sensitive information on you, just the information referred to above which is necessary to supply you with information we are required to send you in the normal operations of business or information you have opted to receive.

We do not sell or make available any of your details to others such as direct-mail or other marketing companies. We may only disclose your information to, for example, a corporate client on whose behalf we may manage your data for example you as an investor. These third-party companies may not disclose or share your details.
